## **Empanelment of Individual Advisors**

### **1. Background-:**

- 1.1. - e) Should be below the age of 65 years.

#### **2.1.2. Minimum eligibility criteria for working professionals (Private Sector)**

- a) Should possess relevant qualification viz. Diploma/ Graduation/ Post Graduation in Engineering etc.
- b) Minimum 10 year's post qualification experience in relevant sectors viz Distribution.

- c) Should be medically fit to carry out the assignment (a self-certification may be obtained in this regard).
- d) Should be below the age of 65 years.

### 2.1.3. Other eligibility criteria

- a) The Individual Advisor must have Goods and Service Tax Registration, unless exempt by law, as on date of being considered for their services to PFCCL.
  - b) The Individuals should not be regular employees in any other company/ establishment.
